OFFICE MEMORANDUM


Subject: Exemption from repeating the Foundation Course.

...

The undersigned is directed to say that the matter of exempting a candidate from repeating the Foundation Course in pursuance of his selection to and joining of another service based on Civil Services Examination, if such candidate has already successfully completed the Foundation Course in pursuance of his selection to and joining of a service based on an earlier Civil Services Examination, has been under consideration of this department. It has been felt that repetition of Foundation Course by a candidate who has already successfully completed the Foundation Course earlier is wastage of resources.


2. Therefore, it is decided that the candidate who has already done the Foundation Course in pursuance of selection to and joining of a service based on an earlier Civil Services Examination would not be required to undergo Foundation Course again upon selection to and joining of another service based on the Civil Services Examination. The performance of the officer trainee in the earlier Foundation Course, successfully completed would be used for determining his inter-se-seniority etc. This arrangement would be operational with immediate effect. The case already settled shall not be re-opened.
